

# Frequently Asked Questions regarding Health Coach Training & the Nationally Accredited, NIWH 3-in-1, 400 hour comprehensive Whole Health Education® training

#### **History of NIWH -**

In June of 1976, rudimentary beginnings of a new movement within health care began. The vision of its' founder was to (1) empower individual patient/clients to have an understanding of the "how" and "why" of their chronic health conditions and (2) be able to take control of their health outcomes with informed, evidence-based, yet *demystified* health information.

In 1977, a Whole Health focused curriculum was offered, and informally 12 health care professionals participated in the first cohort of a two (2) year Whole Health Education training. By word of mouth alone, in 1978, thirty three (33) health professional learners signed up for the training.

The program rapidly expanded and in 1980 NIWH began a nine (9) year collaboration with the <u>Lemuel Shattuck Hospital</u>, Out Patient Stress and Pain Clinic, in Boston, Massachusetts to pilot test the Whole Health Education model with inpatient and outpatient populations.

The program grew rapidly, and between 1980 and 2018 many hospital studies were conducted around the country. In 1998, Whole Health Education® was named a Best Practice in Relationship Centered Care by Union Hospital, a Boston area Harvard affiliate hospital, which opened a department of Whole Health Education to empower and serve its outpatient population.

The last study was completed and published in 2018. This study was conducted in collaboration with Michigan State University, College of Human Medicine, and physician practice:

In addition to being the only post-professional, ICE nationally accredited program of its kind, NIWH is endorsed, accredited and approved by the leading healthcare organizations across the country. The leader in patient education, health advocacy and innovator of whole health coaching, NIWH is the 44 year old voice of patient and health advocacy called upon by the major nursing organizations and state nursing groups to provide free webinars for understanding the legal, professional and ethical details as it relates to health professionals use of health coaching.

Nurse graduates may elect to become <u>Board Certified Nurse Coaches</u> through the American Nursing Association's AHNCC board, <u>Board Certified Holistic Nurses through AHNA</u>, <u>Board certified Patient Advocates through the Patient Advocate Certification Board (PACBoard)</u>, and can test out for a <u>National Certification as a Chronic Care Professional with a significant discount, through the HealthSciences Institute, an NIWH Education partner.</u> All of the above certifications are elective and are not required for an NIWH graduate to receive their NPI number or liability insurance.

### **History of Coaching**

The term Coaching, utilized outside of the field of sports, was first adapted to the business world and utilized by the <u>International Coaching Federation</u>, founded in 1995. This training focused, and continues to focus, on executive, leadership and life coaching. There are <u>three credentialing paths</u> to credential with ICF in these areas of coaching:

Associated Certified Coach Professional Certified Coach Master Certified Coach

The definition of the Essence of Coaching, as stated by the <u>International</u> <u>Coaching Community</u> is:

- > Help a person change in the way they wish and help them go in the direction they want to go.
- > Coaching supports a person in becoming who they want to become.
- > Coaching builds awareness, empowers choice and leads to change.

PLEASE NOTE – there is no Health or Wellness Coaching accreditation from the ICF. Only accredited CEUs for certified ICF credentialed coaches.

NIWH is approved for and supports the American Nursing Association's AHNCC national board certification for nurses. NIWH believes in a standard of training and credentialing that is appropriate to work within medicine.

Although NIWH served as a founding board of NCCHWC, NIWH has chosen to not apply for NCCHWC acceptance as NIWH believes the pre-requisites are inadequate for professional success and recommends AHNCC instead.

#### **History of Health Coaching**

Until the late-2000's Health Coaching was not part of the health care landscape or language. In 2008, <u>Dr. Jerold Lamole</u>, a renowned cardiac surgeon, who was part of the medical team that performed the first 1968 heart transplant in the United States, invited NIWH to participate in the upcoming initial meetings. As the oldest, post professional program of its kind, NIWH was asked to provide input and share our experience for developing a national organization, as well as creating guidelines for professionally recognized health and wellness credentials.

NIWH was introduced to Dr. Lemole through its affiliation with Health Corps, founded by Dr. Memet Oz. NIWH was providing Whole Health Education training for the HealthCorp interns from 2008- 2014. Healthcorps became accredited by ICE in 2019 and provides a certificate for an eight-hour, assessment-based training that gives participants the tools and techniques needed to facilitate the HealthCorps Whole Health content.

On October 16<sup>th</sup> of 2009, a meeting to establish a leadership team for the development of a national consortium to credential Wellness Coaches was convened. Distinguished members included:

The National Institute of Whole Health served on the Board of Directors and on the Council of Advisers from 2009 - until January 2014. NIWH left the consortium in 2014, as NIWH believed a strong foundation in patient health education and patient advocacy was critical to the long term success of an emerging new specialty.

NCCHWC did not wish to have any focus beyond health coaching skills as the central part of an accepted training. In fact, the guidelines state "more than 75% of each [coaching] session is devoted to coaching facilitation and not education." https://www.ncchwc.org/individuals/

NIWH left the consortium because of its commitment to patient health education and health advocacy, which the NCCHWC board did not wish to have included in the definition or function of health coaching.

The NIWH clinical studies evidence that demystified patient health education, which clarifies the *How* and *Why* of a client's chronic health condition, is critical for clients to understand in enabling them to make *sustainable changes* in their lifestyle choices.

# To apply to sit for the Health & Wellness Coach Certifying Examination, you will need to provide:

- Documentation of an Associate's degree or higher in <u>any</u> field. For those who do not have an Associate's degree, exam candidates will need to provide documentation of 4,000 hours of work experience in <u>any</u> field. If you have completed an associate degree or higher, please complete the <u>HWC Education Declaration document</u>. [Only] 10% of all exam applicants will be audited and asked to provide a transcript of their highest degree. If you have not completed an associate degree or higher, please complete the <u>HWC Work Experience document</u>.
- A certificate of completion from an Approved Transition Program. If your program has an asterisk next to it, please include documentation of

completion of the additional requirement. If you do not have a certificate of completion from the program you attended, the NCCHWC will contact your program for verification.

**Given the lack of substantive pre-requisites** for training and certification, interest in Health Coaching has increased significantly over the past 10 years. NIWH, the pioneer of Whole Health since 1977, is the current leading voice for clarifying and educating health professionals on the parameters and realities of training and credentialing for Health Coaching.

For the past 3 years, NIWH has been providing, to the leading national nursing organizations, webinars regarding the topic of health coaching and the professional, legal and ethical parameters around health coaching - both for nurses and other credentialed medical professionals.

The most rigorous and best credentialed board certification for nurse coaches is through the American Nursing Association.

#### IMPORTANT CURRENT BILLING INFORMATION

There has been considerable reporting regarding the recent assigned Category III CPT® Codes for health coaching utilization. NIWH is partnered with a nationally credentialed medical billing and coding expert who is the former Billing and Coding Compliance Officer of the Harvard Medical School affiliated Boston's Children's hospital. Each year he reviews and updates the content of the NIWH Billing manual, which is provided without cost to program graduates.

Here is the most relevant information, provided by our expert, from the CPT code announcement, as it pertains to legal billing practice:

"The approved Health and Well-Being Coaching Category III CPT® codes will be in effect for five years. These temporary codes are intended to support the utilization and data collection, required for AMA approval of Category 1 codes. Reimbursement by payers of Category III typically waits until codes have been certified as Category I." **PLEASE NOTE** - This takes considerable time, a minimum of 5 years, and if approved for Category I status will likely be utilized under the umbrella of a physician or similarly credentialed medical practitioners. In addition, the amount of reimbursement will reflect the complexity of training and prerequisites and likely to provide a minimal reimbursement to or through a medical physician (or equal status) only, for such health coaching services.

Unlike a health coach, graduates of the NIWH program qualify for healthcare provider status, professional liability, an NPI number as a patient health educator, and receive an expert prepared billing and coding manual.

# Latest update from NBCHWC, January 26th newsletter

"As of April, 2021, a taxonomy code for health and wellness coaches has been created. NBCHWC is working to have coaching billed for by physician or medical practices in the next few years. This will require, as with nurses, coaches be assigned an NPI for the billing of their services through the medical practice in which they work.

As with nurses working in a medical environment, health and wellness coaches will need an NPI number - when the services become approved for medical reimbursement - if they work for a healthcare organization or in partnership with a physician." [This is still several years from 2021.]

In 1980, NIWH developed and researched the first Health Coaching communication model, Behavioral Engagement with Pure Presence (BEPP). BEPP is a component of Whole Health Education – the first actual health coaching model to be developed in the U.S. NIWH is the pioneer of whole person health education model that has been developed and researched in clinical settings. In addition to BEPP, NIWH Whole Health Training provides demystified, whole-person health information which includes both medical and alternative self-care options.
